

7TH ANNUAL MORRIS HILL CRAFT MARKET & QUILT SHOW

Thank you for your interest in our Craft Market! There are lots of changes for 2022, so please read carefully:

- **The Craft Market is now a juried, invitation only show - this means that ALL vendors, including returning vendors will need to email FOUR pictures of your work, and a picture of your booth.** (*Don't send in more than four*) These are the four pictures that we will post on social media, if you are invited to participate.
- **Jurying means a higher quality fair, likely to attract fewer sightseers and more serious buyers.** In some cases, crafts may be declined simply because of space restrictions or an overabundance of submissions in a particular category.
- **Completed and signed applications are due** no later than June 6, 2022, **to our new Market Director, Kat Morris** (address and email below in green and on next page)
- **Participating vendors will be given two meal vouchers, upon registration, to use in our Live2Serve Café.** (*main item, chips, and drink*)
- **We have added 8 booths.** Maps will be sent to participating vendors.
- Booth fees, **payable to Morris Hill Baptist Church, will be due by July 30, 2022, once accepted.**

Application Deadline June 6: \$75 per booth (10 X 10' with space between booths to avoid crowding), or \$150 for a double booth (10' x 20'). Notification of status will be mailed no later than July 1. **PLEASE DO NOT SEND IN FEES UNTIL YOU HAVE BEEN INVITED TO PARTICIPATE** Prior participation is not a guarantee of acceptance in the 2022 Craft Market. Previous participants may request a location and requests will be granted when possible. No refunds after July 30, 2022. "No-shows" forfeit booth fee. Once accepted, your booth fees are due by July 30, or your space will be awarded to another vendor.

ELECTRICITY is available in limited areas for a \$10 additional fee.

- **At least 75% of your booth needs to be your handmade items (NEW!).** We understand that sometimes carrying a few items related to your handmade items helps them to sell. Your "other" items must be related to selling your handmade items. Example: Jewelry sales can include chains. Photography sales can include manufactured frames; prints are acceptable if from artist's original work. Please contact Craft Market director with any questions. All non-handmade items must be approved. All booth items should be of excellent quality and design. All other resale items, buy/sell imports, or commercially produced products are not allowed. Displaying products that appear to be mass produced and unrelated to your handmade items will not be accepted. The Craft Market Committee reserves the right to ask any artist to remove items that do not meet these guidelines or are deemed inappropriate for family viewing.

- **Check-in/Set-up:** Check in at Craft Market registration table in the main hall/entrance to the gym. Food vouchers will be given to participating vendors at this time. **Set-up Thursday, Sept 29, 3-8pm or Saturday morning, Sept 30, 8:30-10.** UNLOAD then MOVE your vehicle before setting up. Be open for business by 10 am Friday and Saturday. Vendors are expected to be there both Friday and Saturday. No early take-downs.

- **Booth Set-ups:** Artists must provide their own tables and chairs. Please provide BLACK table covers that go to the ground to hide boxes and other items. We will provide space between booths for viewing and visitor access. Have enough products on hand for the entire time. Early closing will jeopardize future participation.

* **Sharing a Booth:** Two artists may share a booth. Each artist must submit an application, and images/photos of his/her work. Artists sharing a booth only submit one check for booth fee.

- **Photographs/Images of work** must represent the work that you have created over the past 5 years and is representative of the work that you will exhibit and sell. **Email four images/jpegs of artwork, PLUS one of your booth display,** as part of your application and send to kat.morrishillcraftmarket@gmail.com, OR mail a USB flash drive or photos with your application to **Morris Hill Craft Market c/o Kat Morris, 37 Dove Drive, Ringgold GA 30736.** In the body of the email, please be sure to include your Name and/or Business Name as written in your application to ensure we match up pictures with the correct vendor.

Keep in mind that images/jpegs from accepted artists will be posted on our Morris Hill Craft Market Facebook page and event page for promotional purposes.
